

THE COMPANY



The client is a leading footwear manufacturing company and were looking for a suitable CLM software company to automate their contracts. Their operations were growing at a fast pace, they had multiple business brands and verticals and it was getting very difficult to keep track of contracts.



THE CHALLENGE

Business, legal and vendors worked on multiple drafts making the version management of the contract tough for the legal team

Requirement

No approval flows. Approvals were taken ad-hoc without any delegation of authority matrix

Contracts were executed online but there was no central repository of the contracts

They had a spreadsheet based tracking of renewals / expiry of contracts. Employees had to manually schedule reminders for renewals. This often led to missing contract renewals.

The contracts in WIP had to be tracked manually. Thereby, delaying the negotiation and execution process.

Volody CLM Solution

A standard workflow was defined for each type of contract. This workflow was then configured in the software to make it easy for the users to identify the approvers and signatories for their contracts

A central repository was created which was made searchable by OCR technology.

Reminders for expiry and termination were preset in the software as per the defined escalation matrix.

Online collaborative drafting and negotiation of the contract was introduced. Due to this all the versions were stored in the same software. All the changes were auto-saved in track mode.
